Deputy Director, Department for Work and Pensions (UK)

Cathy Payne has had an extensive career in the UK civil service working on a range of social policy issues. She currently has responsibility for the UK State Pension policy and recently led the last Government review on State Pension age.



Ole Settergren

Head of the Analysis Department, Pensions Agency (Sweden)

Ole Settergren had a key role in the major Swedish pension reform in the late 1990s. He was one of the main architects behind the Notional Defined Contribution plan that was implemented after the reform. Since the reform, he has held different positions at the Swedish Pensions Agency. He is currently Head of the Analysis Department.



Franck von Lennep

Head of Social Security Department (France)

Franck von Lennep is the current director of Social Security (DSS), the French Department in charge of health care financing, social benefits, workers' compensation and pensions. Between 2017 and 2020, he was chief of social affairs in the French Prime Minister Office in charge of supervising social policy, including pension reforms.

How to come to Paris School of Economics



From Roissy Charles de Gaulle airport

take RER B (south direction) to Cité Universitaire (via Paris).
You can also use a Car Air France (bus) to Montparnasse, then subway line 4 (south direction) to Porte d'Orléans. Travel duration : 1 hour.



From Orly airport

take an Orlybus bus to Paris, and get out at "Tombe Issoire" (it is the first stop within Paris' confines). Travel duration : 45 min.



From Gare du Nord train station

take RER B (south direction) to Cité Universitaire (via Paris).
You can also take subway line 4 (south direction) to Porte d'Orléans.
Travel duration : 30 min.



From Gare de Lyon train station

take RER A (west direction, end of the line is Cergy-le-Haut) ; change at Châtelet Les Halles ; take RER B (south direction) to Cité Universitaire.
You can also take subway line 14 (Saint Lazare direction) ; change at Châtelet ; take subway line 4 to Porte d'Orléans. Travel duration : 45 min
